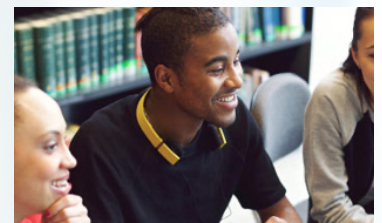
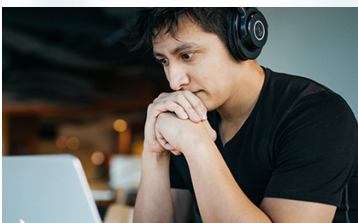
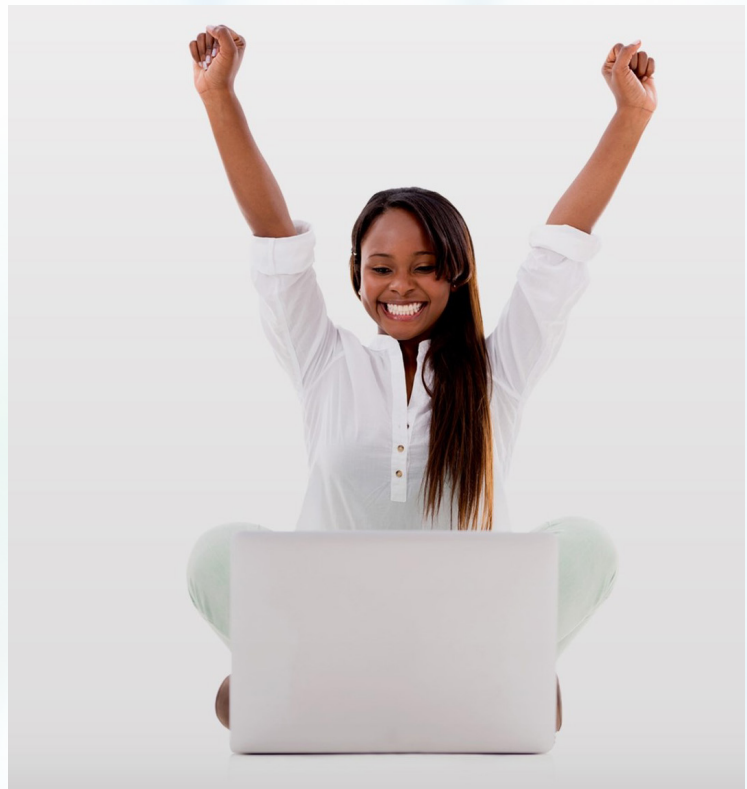

Did You Know...

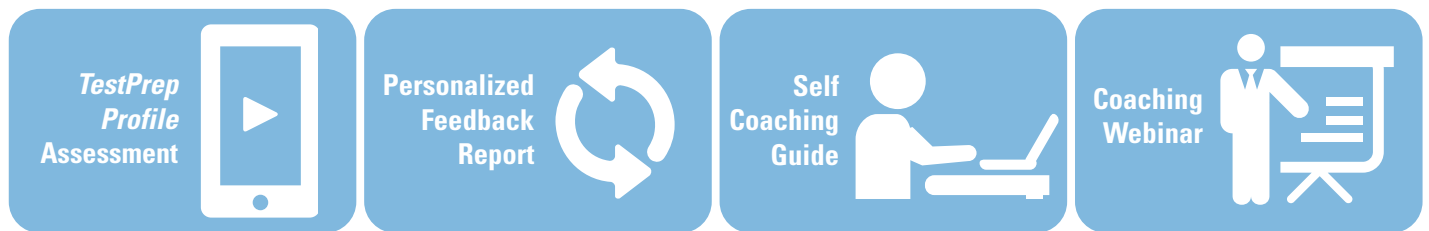
- Employers must adapt quickly to retain their talent during this time known as “the Great Resignation”

- Chipping away at inequities in the test-taking process is an important goal of FifthTheory and the TMI program.

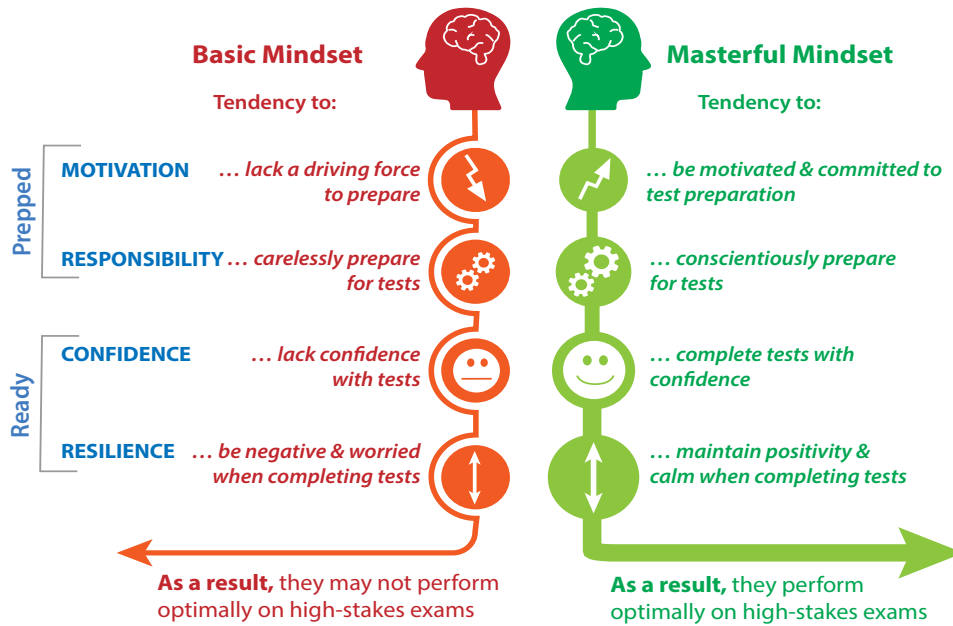
